






Figure 1. Switching Time Test Circuit


V_{CE}, Collector to Emitter Voltage (V)

Figure 2. I_C - V_{CE}




V_{CE}, Collector to Emitter Voltage (V)






Figure 6. h_{FE} - I_C




I_C, Collector Current (A)




Figure 20. P_C – T_C

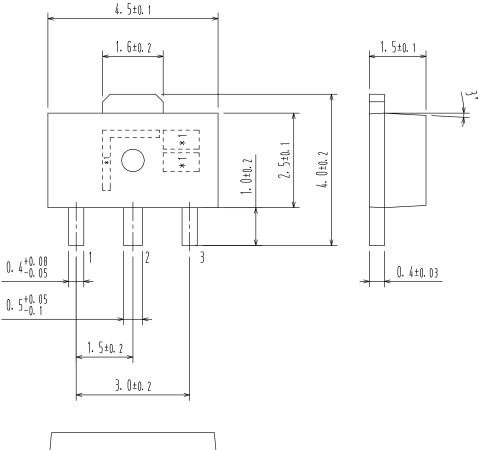

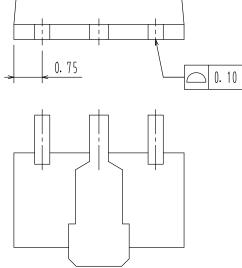
