We are aware of the potential supply shortage of rare earth elements and their use in the production of electronic products. onsemi has identified that less than 1% of our products are using rare earth elements for its backend material. We are aware that our supply chain has enough existing supply to support the manufacture of the affected products. Through our Enterprise Risk Management (ERM) framework, tools and processes, we identify the loss of critical supplies as a risk that is managed, mitigated and tracked within the supply chain planning, sourcing and procurement groups and reported on a quarterly basis.
